 I, _____, state that if ever this application is approved, I bind myself to the following conditions, viz;

1. To abide by the Articles of Incorporation, the By-Laws and the Rules and Regulations of the Cooperative now existing as those that may in the future be adopted;
2. To observed the terms of this service contract including, among other things, paying my monthly electricity bill promptly and honesty;
3. To take proper care of metering or other equipment that the cooperative installed in my premises;
4. To inform the Cooperative and or proper authorities of any theft or pilferage of electricity or any damages caused by any person to the electric meter and equipment appurtenant thereto;
5. To cooperate with the support program on the wise and efficient use of electricity;
6. That if in case, I should change the name of my establishment and/or change the classification of my Service Connection from either Residential to Commercial/Industrial or vice versa. I agree to execute a new contract under the name of the new establishment and/or the new classification as the case maybe and that the failure on my part to abide by this provision shall give rise to the right of the Cooperative to disconnect my electric service connection.
7. To allow during reasonable time of the day or night the representatives/employees of the cooperative and upon their latter's demand upon me or any of my household of sufficient age and discretion to enter my premises/residence for the purpose of collection, disconnection, installation, repairing, wiring connection/outlet inspection, load inspection/computation, meter reading, violation of contract or RA 7832 and for any such other purposes related to the Cooperative's function. I further agree that refusal on my part or by any member of my household to effect the herein mentioned purposes shall be a ground for the cooperative to immediately discontinue electrical service and/or refusal for further recommendation of electric services;
8. To grant the Cooperative the right to determine the location and relocation of the electric meter;
9. To pay the Cooperative of any damages or loss of its property due to negligence or misuse on my part, my employee/s or member/s of my household;
10. To pay any billing adjustment in case there is a stoppage or failure of my electric meter to register the full amount of energy consumed with or without any fault on my part;
11. To allow the Cooperative, if necessary, to construct its pole lines, circuits and to place its transformer, apparatus on my property or within my buildings, at a point or points convenient for such purpose;
12. To be held responsible and/or desist from violating Section 2 of RA 7832 and to answer for the violation on the part of my employee/s or member/s of my household of the aforementioned provision which is entitled "Illegal Use of Electricity" described as follows;

The following circumstances constitute prima facie evidence of illegal use of electricity:


- a. Tap, make or cause to be made any connection, with overhead, lines, service drops or other electric service wires without previous authority or consent of the private electric utility or rural electric cooperative concerned;
- b. Tap, make or cause to be made any connection to the existing electric service facilities or any registered consumer without the latter's or the electric utility's consent or authority;


- c. Tamper, install or use a tampered electrical matter, jumper, current reversing transformer, shorting or shunting wire, loop connection or other device which interferes with the proper order whereby electricity is stolen or wasted;
- d. Damage or destroy an electric meter, equipment, wire or conduit or allow any of them to be damaged or destroyed as to interfere with the proper or accurate metering of electric current;
- e. Knowingly use or receive the direct benefit of electric service obtained through any of the acts mentioned in sub-section a, b, c and d;
- f. Allowing other end-users or persons to be connected to my electrical installation/connection, whether for profit or not, without the expressed approval of the Cooperative.
- g. To exempt Cooperative from any liability in case of power interruption beyond its control arising from force majeure or any other fortuitous event;
- h. To grant the Cooperative the right to suspend electric service at any such time, period or manner as in its judgment may be necessary in its operation within the coverage area;
- i. To pay for the replacement cost of electric meters;
- j. To post a bill deposit equivalent to the estimated billing for one month to guarantee payments of bills. The Cooperative may disconnect the electric service notwithstanding the existence of the bill deposit which will serve as guarantee for the payment of future bill(s) after it is reconnected;
- k. The approval of this application/contract by the Cooperative and the undersigned upon the terms herein above set forth and the Contract for electric service shall continue to be in force until term terminated due to permanent disconnection of electric service.
